Hello all members and friends of SBE Chapter 70. I hope you all had some time to relax over the holidays. I'd like to thank WAPS / The Summit and Steve Savanyu for the great meeting in December. Steve's presentation was outstanding, even us microphone geeks learned something. It was also great to see WAPS after their move to the new facil-

In national news, the FCC has extended the filling date for the EAS Test Reporting System (ETRS) Form One to February 28, 2023. This is required to be filed annually, but due to delays in testing the National EAS via a National Periodic Test (NPT) in 2022, the Commission moved the 2022 filing to the new date. The delay was due to continuing Covid-19 issues. FEMA has not yet posted a date for the next national test, but unofficial comments indicate the NPT may occur during the first part of 2023.

There are also reports that uploading of the required Issues and Programs files has been problematic. If your station is having issues, document them and continue to attempt the uploads until you are successful. The FCC only extended those file uploads until January 30th.

The SBE will offer a new webinar on Thursday, February 16 @ 2 p.m. This presentation will focus on the testing, measurement and monitoring of ATSC 3.0 broadcast systems. It will provide a brief overview of the IP and RF signal parameters and discuss the "When, Where and How" of testing, measurement and monitoring of signal elements. These elements must be measured and monitored to ensure standards compliance and interoperability with downstream transmission and receiving devices. Hardware- and software-based devices and systems used to test, measure and monitor the signals will be discussed. A live demonstration of the measurement and monitoring of actual "on air" ATSC 3.0 transmission systems with currently available software-based products will be included.
